RULE FORM

ASTM/SEI approved helmets are required when mounted- no exceptions

Sr. buddies will help Jr. buddy tack horse 1st if they need help.

NO riding double.

Always dismount in the arena you are riding in.

NO running around the barn area!!!!!!!

DO not leave FWF property without permission from staff.

When leading horses, use a halter with lead rope.

Ask permission to go in with your horse if it isn't time to tack up!!!!

NO riding horses in **or** near the barn!!!

Horses that are known to kick must have a red ribbon tied in their tail!

If your horse cribs, or chews on wood you must supply a collar or muzzle.

Only tie horses with a quick release knot, or a tie with safety snap.

No Cell Phones, Radio or CD players.

Label everything!

Fix your bed every morning and clean your private area.

Help team do daily chores.

Pick up after you and your horse.

In bed at 8:30, lights out at 9:00.
